## **Our Work**

- We currently act as a Managing Agent for the International Fund for Ireland (IFI) managing the delivery in Northern Ireland of the IFI Personal Youth Development Programme (PYDP) and the Communities in Partnership (Cross Border) Programme.
- We are working in partnership with Cooperation Ireland and East Border Region to animate and provide support to grassroots communities to access funding opportunities under the SEUPB/Pobal managed Peace Plus Small Grants Programme.
- We are an Open College Network (OCN) accredited centre and deliver the OCN Level 1 in Developing and Managing Community Facilities.
- We undertake various assignments and commissions for central and local government, other statutory bodies and the community, voluntary sector including pilot projects, evaluations, programme design, project assessments & appraisals.
- We deliver our own 'Rural Action Awards' where we give back to communities each year. So far, we have invested nearly £30,000 in community action projects injecting the equivalent of £1,000 per month back into rural communities.

• We design and develop programmes/projects that make a difference in rural communities. We have 3 pipeline projects that, if funded, will make significant impact in rural areas.

We are based in Cookstown, Co. Tyrone however we work on a regional basis across Northern Ireland & the border region and with organisations across Ireland & the UK.

# **ABOUT OUR VACANCY**

### Trustee Roles and Responsibilities:

As a Trustee, you will:

- Provide strategic direction and oversight to ensure the charity fulfils its mission and objectives
- Support the executive team to drive the charity's performance and impact
- Act as an ambassador for Rural Action, promoting our values and work within the region

#### Who Are We Looking For:

- Up to 5 new Trustees to join our Board
- Two of the 5 positions are open to Board apprentices e.g. those who may not have served on a charitable board before who would like the opportunity to gain experience over a 12-month period
- Individuals living in Northern Ireland or Ireland preferably with a rural background/interest in rural development; community development; cross border working and peace building

#### What We're Looking For:

- A commitment to the aims and values of Rural Action
- Individuals with diverse backgrounds and experience
- Experience or a background in any of the following: governance, finance, communications (marketing/PR), social economy, income generation, IT (data management; cyber security), sustainability and the practical application of climate change initiatives within communities
- Strong leadership and communication skills
- The ability to think strategically and work collaboratively

#### Time Commitment:

- The Board meets bi-monthly (6 times a year)
- Meetings typically last 1-2 hours on average
- Majority of meetings are held online, recognising the wide geographic spread of the Board
- 1-2 Meetings per year are held in person at a time, date and venue of mutual convenience to the Board
- Our AGM usually takes place Sept/Oct each year
- Occasional requirement to represent the organisation at events including visiting Rural Action award recipients, attend training, study visits or participate in recruitment/procurement/assessment panels as may be required



#### Term:

- Offer 6 months induction
- Appointments will be based on a 3-year term with option to extend for 1 further
  3-year term subject to normal Board review processes
- Apprentices will be co-opted for an initial 12-month period with the option for extension to a 3-year term on completion of the voluntary apprenticeship
