Role Summary

We are looking to add to our team of school counsellors. We are seeking counsellors who have a vision, desire and ability to make a difference in young people's lives. We are interested in people who are committed to excellence, best practice and who are willing to work alongside our dynamic team to make this happen.

Key responsibilities

- Deliver an agreed number of counselling sessions, drop-in's and group work for young people referred to Familyworks' School Counselling Program, in a Post-Primary school setting
- Develop effective working partnerships with senior management and teaching staff to ensure delivery of a high-quality service in schools
- Work within agency policies, standards and procedures for service delivery
- Deal with risk and safeguarding issues in accordance with legal and ethical requirements, in consultation with Familyworks management
- Liaise as necessary, within the bounds of confidentiality, with members of staff and other appropriate individuals including health, welfare and other agencies
- Record data electronically
- Typically counselling takes place on school premises and during school hours inclusive of the hour immediately after school ends

Role Requirements

Therapeutic Service Delivery

- Promote the school service with parents, pupils and staff in designated schools in appropriate ways
- Assess the needs of clients and provide appropriate therapeutic interventions to meet these needs, primarily through one-to one counselling and in line with the HOPE handbook
- Engage constructively with children, young people and adults from a diverse background, promoting anti-discriminatory and anti-oppressive practice
- Develop and maintain productive and co-operative relationships with nominated staff and key
 contacts in designated schools and work pro-actively with key contacts to manage the referrals
 process and to ensure optimum service delivery within the parameters of available resources
- Maintain best practice as a counsellor while working sensitively as part of the pastoral care teams in schools



- Manage risk and safeguarding issues in accordance with appropriate legal and ethical requirements
- Maintain appropriate records of counselling activities including case notes in accordance with Data Protection using the company's secure database
- Be willing and able to travel to identified schools, and to maintain a flexible attitude
- Liaise as necessary, within the bounds of confidentiality, with members of staff and other appropriate individuals including health, welfare and other agencies
